CONDITIONS OF SALE

1. This sale by Public Auction is made by **RHB BANK BERHAD** (the Assignee/Bank) in exercise of the rights, powers and remedies conferred upon the Assignee/Bank pursuant to the **Facilities Agreement (3rd Party), Deed of Assignment (3rd Party Assignment) and Power of Attorney (3rd Party) all Dated 03rd Day of January, 2017** executed by **DING YIYUE & DING JINGAN** (the Assignor/Borrower) and in favour of the Assignee/Bank and is made subject to all conditions and category of land use, express or implied or imposed upon or relating to or affecting the property.
2. Subject to the reserve price, the highest bidder being so allowed by the Auctioneer shall be the Purchaser but the Auctioneer reserves the right to regulate the bidding and shall have the sole right to refuse any bid or bids without giving any reason for such refusal. The Auctioneer reserves the right to alter or add to these conditions of sale at any time prior to the sale. 6. The bidder with the highest bid shall be declared as successful bidder upon the fall of hammer.

16.
