## **CONDITIONS OF SALE**

#### 1. THE PROPERTY AND THE RESERVE PRICE

- 1.1 The property, the particulars of which are as described in the Proclamation of Sale ('the Property') is put up for sale by way of public auction ('the Auction Sale') subject to the reserve price as stated in the Proclamation of Sale ('the Reserve Price').

#### 2. THE AUCTIONEER

#### 3. BIDDING DEPOSIT

#### 4. <u>BIDDERS</u>

- In the event that the Auctioneer in his absolute discretion so request, the intending bidders shall deposit with the Auctioneer a photocopy of their respective identity cards.
- 4.3 In the event that an intending bidder is bidding at the Auction Sale on behalf of another party, such intending bidder ('the Agent') shall be deemed to be an agent of the party for whom he is bidding the Property for.
- For Bumiputra lot or if the sale is restricted to Bumiputra only, only Bumiputra is allowed to purchase or to bid or to act for and on behalf of the bidder. For Malay Reserve Land or Native Land, only Malay or Native is allowed to purchase or to bid or to act for and on behalf of the bidder. #### 5. PERMITTED PURCHASER

- 8.7 In the event that the Purchaser shall fail to deposit the Purchase Deposit Shortfall or shall fail to execute the Memorandum for any reason whatsoever or in the event of the bank draft and/or cashier's order for the Bidding Deposit and/or the Purchase Deposit Shortfall is dishonoured for any reason whatsoever when presented by the Bank for payment, the Purchaser shall be deemed to have committed a breach of the terms of the Auction Sale and the consequences set out in paragraph 8.8 hereto shall ensue.
- In the event that the Purchaser shall commit a breach, the Bidding Deposit shall be forfeited absolutely to the Bank and the Bank may in its absolute discretion upon such terms and conditions and at such time or times the Bank deems fit put the Property up for resale. The Bank shall be further entitled to recover from the Purchaser all costs and expenses of, in connection with and resulting from such resale. The Purchaser shall be further liable to the Bank for any shortfall in the sale price obtained at the resale and the Purchase Price ('the Resale Shortfall').
