### **CONDITIONS OF SALE**

- 1. - 6. The bidder with the highest bid shall be declared as successful bidder upon the fall of hammer.

In default of such payment of the balance of the purchase price within the time and in the manner stipulated in Clause 11 above, the deposit paid pursuant to Clause 8 above shall be forfeited by the Assignee and the property may be put up for re-sale at a time, place and reserve price to be fixed by the Assignee at its sole discretion.
